Dear Mr. Blake:

I submit this focus letter in advance of the argument set for February 5, 2020. I also list new authority that may be applicable to the issues raised.

- 1. Defendant's in-custody statements to Detective Kusch were obtained in violation of Miranda, and violated defendant's rights not to incriminate himself, to counsel, to due process, and to a reliable penalty determination under the Fifth, Sixth, Fourteenth, and Eighth Amendments. (Heading IX of the Appellant's Opening Brief, at p. 170.)
- 2. The striking of a juror who did not favor the death penalty, but who could consider death as a sentence under the circumstances of this case, denied defendant his rights to due process, to an impartial jury taken from a fair cross-section of the community, and to a reliable penalty determination. (Heading I of the Appellant's Opening Brief, at p. 54.)
- 3. The trial court's failure to apply Witherspoon/Witt evenhandedly and impartially violated defendant's rights to due process, to a reliable penalty determination, and to a fair and impartial jury under the Sixth, Eighth, and Fourteenth Amendments to the United

States Constitution and Article I, sections 7, 15, 16, and 17 of the California Constitution. (Heading I of the Appellant's First Supplemental Brief, at p. 1.)
