Dear Mr. McGuire:

By appointment of this Court, I serve as counsel to Daniel Nunez, the appellant in the above-referenced automatic appeal. The court has scheduled oral argument in this matter for April 4, 2013. Please inform the court of the focus issues listed below. The Appearance Page and an Application to Divide Oral Argument Time with David Goodwin, counsel for coappellant Mr. Satele, are attached.

I would be pleased to respond to questions from the Court regarding any of the issues raised in the appeal, but I anticipate focusing my argument primarily upon the following issues, referenced here by the roman numeral used in the opening brief:

- I. The court incorrectly instructed the jury on the personal firearm use enhancement (Pen. Code, § 12022.53(d)(e)(1)) when it failed to define essential elements of the enhancement.
- IV. The court incorrectly instructed the jury on the gang enhancement (Pen. Code, § 186.22, subd. (b)) when it failed to define essential elements of the enhancement.
- V. The court incorrectly instructed the jury on the mental state required for accomplice liability when a special circumstance is charged (CALJIC 8.80.1), which allowed the jury to return a true finding based on a legally incorrect theory.
- XX. The court incorrectly instructed that a person who aids and abets is "equally guilty" of a murder committed by the actual killer (CALJIC No. 3.00).
