## Dear Mr. Navarrete:

This letter specifies the issues on which I expect to focus during oral argument on June 1, 2021, at 1:30 p.m. As respondent's counsel, I intend to focus on the following issues raised in appellant's opening and reply briefs and the Court's directive contained in its May 24, 2021 letter:

- I. Appellant's argument that the trial court erred when it failed to conduct a hearing into appellant's competency to stand trial (AOB 88-109);
- II. Appellant's argument that the trial court committed reversible error when it failed to conduct a hearing into appellant's competency to waive his right to counsel (AOB 110-124);
- II. Whether, assuming this Court concludes that the trial court erred in finding appellant competent to stand trial without holding proceedings under Penal Code sections 1368 and 1369, a remand is appropriate to allow the trial court to consider the feasibility of holding a retrospective competency hearing (see AOB 90-91; RB 115-118).

In addition, I will be prepared to address any other matters of interest to the Court.
