Dear Mr. Ohlrich and Ms. Jameson:

The above-entitled capital case has been placed on the Court's calendar for oral argument at 1:30 p.m. on May 31, 2012. Counsel requests 45 minutes for oral argument.

The oral argument will focus on the following issues raised in Appellant's Opening Brief ("AOB"):

- 1. The assignments of error raised under Headnote I in the Argument in the AOB, and more specifically,
 - a. Whether the lacunae in the appellate record of the six-plus hours of audio tapes of hostage negotiations and conversations with Defendant Houston during the incident, and of the aural content of the videotaped interrogation of Defendant Houston fatally prejudice Defendant's constitutional right to full appellate review;
 - b. Because the jury was not provided with a settled transcript of what on the tapes was intelligible and what was not intelligible and thus to be ignored, nor instructed accordingly, the jury's verdicts are necessarily based upon speculation and conjecture, not admissible evidence, and the resulting judgments were rendered in violation of Defendant's due process rights;
 - c. Given the numerous transcription errors admitted by Respondent, the trial court committed prejudicial error by not ascertaining that the prosecution transcript of the videotaped interview (Exhibit 89) accurately represented what was said on the videotape before permitting it to be used by the jury in deliberations.

- 2. The assignments of error raised under Headnote VI in the Argument in the AOB that the evidence was insufficient to support verdicts of first degree murder, as well as the manner in which the absence of a complete record prejudicially interferes with the ability of the Court to resolve that issue on appeal.
- 3. The assignments of error raised under Headnote VIII in the Argument in the AOB that by stating to the jury his scornful opinion of mental health testimony the trial judge fatally poisoned all three phases of the trial, as well as the manner in which the absence of a complete record prejudicially interferes with the ability of the Court to assess the prejudice flowing from that error at the guilt, sanity, and penalty phases of the trial.
