This letter constitutes my "focus letter" for the oral argument in *People v. Wycoff* scheduled for the afternoon of June 1, 2021.

As counsel for Appellant, I only intend to address the first argument raised in Appellant's Opening Brief. That argument is captioned as follows: "III. The Trial Court(s) Committed Numerous Instances of Reversible Error When They Failed to Conduct a Hearing Into Wycoff's Competency to Stand Trial; (2) Failed to Conduct a Hearing Into Wycoff's Competency For Self-Representation; (3) And Applied an Incorrect Legal Standard." This argument is set forth at pages 58-123 of Appellant's Opening Brief.

In addition, the Court sent a letter to counsel on May 24, 2021, asking counsel to address whether a remand was appropriate to allow the trial court to conduct "a retrospective competency hearing."
