

Dear Mr. Navarrete:

The Court has requested that counsel advise the Court and opposing counsel of those issues on which counsel expects to focus at oral argument, calendared for December 1, 2020, at 9:00 a.m., in San Francisco. As counsel for respondent, I intend to focus on those issues raised by appellant and the Court at oral argument. Specifically, I will respond to the following issues on which appellant intends to focus:

Argument 7 (AOB 235-264): Appellant's argument that Juror No. 9 committed prejudicial misconduct by intentionally concealing during trial her prior experience as a death penalty juror, though she remembered it during trial and had been asked to disclose it during voir dire;

Argument 13 (Supp. AOB 10-20): Appellant's argument that even if Juror No. 9 unintentionally concealed her prior experience as a death penalty juror, that concealment still amounted to misconduct, which created a presumption of prejudice that the prosecution failed to rebut; and *People v. Byron Wilson*, Case No. S087533 November 17, 2020 Page 2

Argument 14 (Supp. AOB 21-22): Appellant's argument that Juror No. 9's misconduct prejudiced appellant because it denied him the opportunity to use a peremptory challenge.
