Pursuant to rule 8.200 (a)(5) of the California Rules of Court, appellant David Lee, Jr. joins and incorporates by reference, as in his previous joinder in the Court of Appeal, arguments I, II, III, IV, VIII, IX, X, and XI in co-appellant Joseph Dixon's petition for review. The Court of Appeal has specified in its opinion, filed April 26, 2012, that appellant joined in these arguments. As in appellant's joinder below, appellant reiterates that the errors, alone and cumulatively with the other errors in this case, denied him his Sixth and Fourteenth Amendment rights to due process and a fair trial, a jury determination on all issues beyond a reasonable doubt by an impartial jury and to confrontation of the witnesses against him. As also argued in appellant's joinder below, if appellant's counsel forfeited any of these issues, counsel rendered ineffective assistance under the Sixth and Fourteenth Amendments.
