TO: THE CHIEF JUSTICE AND ASSOCIATE JUSTICES OF THE CALIFORNIA SUPREME COURT

Petitioner, through his counsel, pursuant to Rules of Court, Rule 8.809, respectfully requests that this court take judicial notice of the attached court records, the case prints from Riverside Superior Court cases RIP1500644 and MCW1600037. These records are of substantial consequence to the determination of the action insofar as they demonstrate that no order lawfully confining Petitioner as a “proposed conservatee” was ever made and illustrate the fallacy of Real Party’s contentions that the superseding indictment was filed for the purposes of “relitigating” Petitioner’s competency to stand trial on the criminal charges and that, upon a finding of incompetency, he would have been ordered released. The


relevant events, reflected in entries made in the court's official minutes of the respective actions, occurred *after* the order underlying the writ proceedings below was made by the criminal court, and therefore they were not presented or considered by the trial court or the Court of Appeal.

These records are judicially noticeable under Evidence Code sections 452, subdivision (d)(1) and 459, subdivision (a).

to stand trial on that date, he was merely returned to Patton via the San Bernardino order that was already in place. It is not until 3/29/12 that the Riverside court committed Mr. Jackson to Patton under its indictment.
