OPPOSITION TO MOTION FOR JUDICIAL NOTICE

Appellant's counsel appears to be confused by the procedural history leading up to this Court's grant of review of the instant action. This is likely due to the fact that Appellant's counsel was only recently retained in connection with Appellant's petition for review with this Court.

The fact of the matter is that Appellant's prior counsel dutifully filed Form APP-003 "Appellant's Notice Designating Record on Appeal" (the "Designation"), and the Designation *did not* include the records that Appellant now states were "inexplicably" left out of the record by the Tuolumne County Superior Court. These records were simply not designated by Appellant in the appeal. A true and correct copy of the Designation is attached as **Exhibit "A"** to the declaration of Eric T. Nielsen filed herewith.

More importantly, Appellant suggests that the documents in which Appellant would like this Court to take judicial notice of, stem from the same case between Appellant and Respondents in the Tuolumne County Superior Court.

They do not. The cases that Appellant states are one in the same in the Tuolumne County Superior Court have entirely different parties, and entirely different facts. Specifically, the instant action arises out of a case filed by Appellant against Jana Susan Jennings, individually and Shana Lee Wren, individually. The case filed by Dana Anthony Berry, Sr. was against only the Maynord 1986 Family Trust as amended and restated.

Furthermore, Dana Anthony Berry is unequivocally a named beneficiary in the Trust instrument at issue in this matter whereas Appellant is unequivocally not. Taking judicial notice of documents that Appellant herself did not designate in the record on appeal, and that relate to a separate action, with distinct and different facts and parties will effectively confuse the issue being considered by this Court because in one case (Mr. Berry's case), he is an actual named beneficiary, and in the other case (Appellant's case being reviewed by this Court), Appellant is *not* a named beneficiary.

Notwithstanding the foregoing, Respondents do not object to inclusion of the single document Appellant has identified as not being part of the Tuolumne County Superior Court record (i.e. the Probate Code 16061.7 Notification of Trustee). This is relevant to this Court's review. However, Appellant's statement that she only found out that she was disinherited by this Notification of Trustee is absolutely inconsistent with the actual facts, including without limitation the statements made by Appellant in Appellant's e-mail to Decedent, and others dated May 31, 2013.
