Focus Issues for Oral Argument

Dear Mr. Navarrete:

The Court requested counsel advise it and opposing counsel by letter of those issues on which counsel expects to focus the argument. I intend to focus on the following issues:

- 1. Whether the jury was instructed on an invalid theory in connection with the special circumstance allegation of murder to prevent arrest or escape from lawful custody (Pen. Code, § 190.2, subd. (a)(5)), requiring that the true finding thereon be vacated. (AOB, Arg. 5.)
- 2. Whether the true findings on the gang enhancement in connection with counts 1 and 2 must be vacated because the evidence is insufficient to prove that the shooting was both gang related and committed with the specific intent to promote, further, or assist in any criminal conduct by gang members. (AOB, Arg. 7.)
- 3. Whether the trial court erroneously admitted evidence that appellant sustained juvenile adjudications and was committed a ward of the juvenile court at ages 15 and 16, requiring reversal of the death judgment. (AOB, Arg. 13.)
