<b>General comments</b>	
	The court has not addressed salary inequities since FY07-08. Per our SEIU contract that ended January 31, 2018 the court agreed to complete a classification and compensation study by the end of the contract. The court hired an outside contractor to complete the classification and compensation study during FY17-18 for all positions. The court will implement the salary adjustment recommendations in FY18-19 if funding permits. The company surveyed the salaries of all court positions using the 10 courts outlined in our employee/employer MOUs that were agreed upon for this purpose. Not all classifications required an adjustment. 131.5 staff will receive increases. Of those 27
