Argument II: *People v. Scott* (2015) 61 Cal.4th 363, 379 [claim that the trial court did not conduct adequate voir dire to determine whether a prospective juror's death penalty views would substantially impair his ability to serve as a juror is forfeited absent objection or request for additional voir dire]; *People v. Jones* (2017) 3 Cal.5th 583, 616 [no requirement that the court ask specific questions during voir dire]; *People v. Thompson* (2016) 1 Cal.5th 1043, 1677 [the trial judge who observes and speaks with prospective juror glean valuable information that does not appear on the record].
