Dear Mr. Navarrete:

I represent appellant in the above-captioned case currently set for argument on October 2, 2017. In Argument I of the opening brief, I contended the trial court erred in refusing to discharge for cause two jurors who said blacks and Hispanics were "more likely to be violent" than whites. Pursuant to Rule of Court 8.254 (a)-(c), I am writing to bring to the Court's attention two cases decided after briefing:

- 1) Buck v. Davis (2017) ____ U.S. ____, 137 S.Ct. 759, 775 (defense counsel representing black capital defendant presents penalty phase evidence that blacks are more prone to violence; held, counsel was ineffective for presenting such evidence and "[i]t would be patently unconstitutional for a state to argue that a defendant is liable to be a future danger because of his race.")
- 2) Pena-Rodriguez v. Colorado (2017) ____ U.S. ___, 137 S.Ct. 855, 869 (Mexican defendant convicted of sex crime provides juror declarations showing one juror said "I think he did it because he's Mexican," state court refused to consider the declarations based on state "no-impeachment" rule precluding inquiry into juror deliberations; held, the no-impeachment rule must fall "where a juror makes a clear statement that indicates he or she relied on racial stereotypes or animus to convict a criminal defendant")
