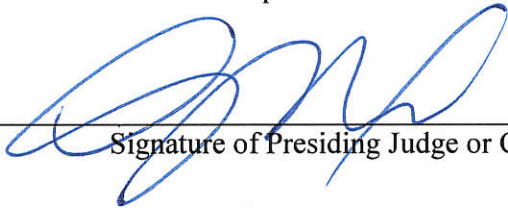
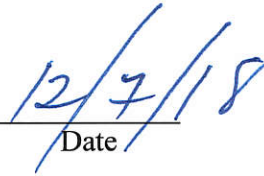


**QUARTERLY FINANCIAL STATEMENT CERTIFICATION**
