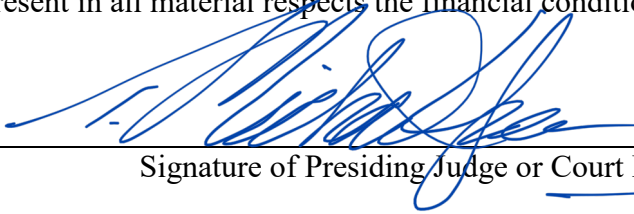


## QUARTERLY FINANCIAL STATEMENT CERTIFICATION
