Example: Types of differential pay (e.g., locality, bilingual, etc.) included in annual salaries.	
1	Bilingual pay of \$50 per payperiod is included in the annual salary for positions designated by the CEO.
2	Realtime Differential of 3% of the salary for Court Reporters that passed the Court-administered test and 6% of the salary for those Court Reporters that are nationally certified is included in the annual salary.
3	Interpreters have a \$1,000 lump-sum payment included in their annual salary for the payment scheduled in February 2013 according to the "MOU Side Letter - Compensation" of the 2012-2104 MOU for Interpreters.
4	The scheduled 2.5% and 5% step increase is included in the annual salary according to each units MOU.
<b>Benefits Worksheets</b>	
Example: Retirement contributions include pension obligation bonds or certificates of participation.	
Salary Driven Benefits include Medicare of 1.45% of the annual salary; Long-term and Short-term Disability Insurance coverage according to the provider limits and the amounts established in each unit's MOU; Court matching funds of 8% for the contributions to the County's 401(k) Salary Savings Plan according to each unit's MOU; and a 0.5% contribution by the Court to the Retirement Medical Trust Fund according to each unit's MOU.	
1	Non-Salary Driven Benefits include subsidies for Medical, Dental, and Vision insurance according to each unit's MOU; a Flex Dollar contribution of \$165 per payperiod for Full-Time employees according to each unit's MOU; Workers Compensation, SDI, and Survivor Benefits according to each unit's MOU; Term Life Insurance benefits according to each unit's MOU; and Educational Differential, Car Allowances, Additional Retirement Contributions and Flexible Spending Account matching according to each unit's MOU.
