# **Cross-Cultural Court Exchanges**

The forum has planned a series of local tribal court/state court exchanges to both model the collaborative relationships among tribal and state court judges at a local level and foster partnerships among tribal and non-tribal agencies and service providers. Through these exchanges, which are judicially-convened on tribal lands, participants identify areas of mutual concern, new ways of working together, and coordinated approaches to enforcing tribal and state court orders. Since no court order is self-executing, these exchanges serve to support both state and tribal courts by ensuring that those who are providing court-connected services are working together to meet the needs of their tribal communities regardless of whether citizens walk through the tribal or state courthouse doors.

Forum members, Judge Claudette White, Chief Judge of the Quechan Tribal Court, and Judge Juan Ulloa, Judge of the Superior Court of Imperial County co-hosted the first exchange. Forum members, Judge Abby Abinanti, Chief Judge of the Yurok Tribal Court and Judge Christopher G. Wilson co-hosted the second exchange. The third exchange will be co-hosted by Judge Richard C. Blake and Judge Christopher G. Wilson. The next exchange is tentatively scheduled on:

# National: Disproportionality Rates for Children of Color in Foster Care 2013 Technical **Assistance Bulletin**

The National Council on Juvenile and Family Court Judges just published Disproportionality Rates for Children of Color in Foster Care Technical Assistance Bulletins, which identify the disproportionality rates for all state and select Model Courts across the Country. This Bulletin, released May 2013, uses the most current (2011) Adoption and Foster Care Reporting System (AFCARS) data and 2011 census data estimates to calculate current disproportionality indexes for every state and select Model Courts across the country. The Bulletin makes comparisons between 2000 and 2011 disproportionality rates to illustrate changes that have occurred in the last decade regarding over-representation of children of color in the foster care system and illustrates the differences in disproportionality rates (when data are available) between the Model Courts and their respective states. # CA: Disproportional Placements of Native American Foster Youth in Non-Native **Homes**

Last year, 439 Native American children entered foster care in California, according to the Child Welfare Dynamic Report System (CWDRS), collaboration between the Child Welfare Dynamic Report System (CWDRS) California Department of Social Services and the University of California at Berkeley. Though the number may seem small, it's disproportionately high, given that Native Americans make up only 1.7 percent of the state's population. See news article

# Edward Byrne Justice Assistance Grant (JAG) Program Deadline: July 9, 2013

The Bureau of Justice Administration posted the FY 2013 State and Local Edward Byrne Memorial Justice Assistance Grant (JAG) Program solicitations and allocations, along with respective application due dates. BJA's JAG Program is a source of federal justice funding to state, local, and tribal jurisdictions and supports a range of program areas including law enforcement, prosecution and courts, prevention and education, corrections and community corrections, drug treatment and enforcement, planning, evaluation, technology improvement, and crime victim and witness initiatives. In FY 2013, there are a total of 56 states/territories and 1,183 local applicants (accounting for disparate groupings) eligible for JAG funds, with a total of \$278.39 million available (approximately \$190 million to states and territories, and \$88.39 million to local units of government).
