## Family Code 4251(c)

- If any party objects to the commissioner acting as a temporary judge, the commissioner <u>may</u> hear the matter and make findings of fact and a recommended order.
- Within ten (10) court days, a judge shall ratify the recommended order unless either party objects to the recommended order, or where a recommended order is in error.
  - In either case, the judge sets the matter for trial de novo.
  - Any party may waive his or her right to the review hearing at any
