Since then, the AOC has been using the policy to guide site selection and acquisition for nine new courthouse projects initially funded in fiscal year 2007–2008. Based on this experience, AOC staff recommend several refinements to the policy to identify the conditions in which sites with various characteristics may or may not be considered, selected, or acquired for court capital projects and to clarify the responsibilities of the AOC and the project advisory group selected by each court in site evaluation and selection.
