Dear Governor Newsom:

The Judicial Council respectfully requests your signature on AB 855, a historic step to make Native American Day an official judicial holiday where all state courts will be closed for business in honor of California's First People and their history.

Sponsoring legislation to recognize Native American Day as a judicial holiday furthers the Judicial Council's mission, as embodied in the council's Strategic Plan, to "remove all barriers to access and fairness by being responsive to the state's cultural, ethnic, socioeconomic, linguistic, physical, gender, and age diversities, and to all people." It also supports the Chief Justice's direction to address bias and racism. Finally, it bolsters the Judicial Council's ongoing efforts to evaluate branch practices, policies, and procedures to identify opportunities to remove barriers to access and fairness while also addressing conscious and unconscious bias, including racism.

Unlike state agency and legislative holidays, judicial holidays are set forth in the Code of Civil Procedure. By updating the Code of Civil Procedure to exchange Native American Day for Columbus Day, AB 855 aligns the judicial branch with the other branches of state government who no longer observe Columbus Day. Both Native American Day and Columbus Day are already official state holidays as defined in section 6700 of the Government Code. This will not
