Subject: Senate Bill 1141 (Niello), as amended June 5, 2024—Support

Dear Assembly Member Kalra:

The Judicial Council is pleased to support Senate Bill 1141, to increase the existing maximum amount in controversy that allows a case to be ordered into mediation by a court from \$50,000 to \$150,000 and to add prerequisites which must be met before such an order is made, because it will allow disputes with relatively small amounts in controversy to have a potentially lower cost means of resolution, providing efficiencies to the courts and allowing timely and cost-effective dispute resolution for the public.

The Judicial Council supported the original legislation Senate Bill 401 (Lockyer; Stats. 1993, ch. 1261) that created the court-ordered mediation provisions to resolve cases in a cost-effective manner. SB 1141 ameliorates the urgent problem of court backlog by updating this 30-year-old statute to a figure slightly above the inflation-adjusted cap and aligns with the increase in the limited civil jurisdictional threshold enacted last year by Senate Bill 71 (Umberg; Stats. 2023, ch. 861). Under current law, court ordered mediation is only allowed for unlimited civil matters, so the current \$50,000 limit is very narrow and would only allow for this service to be provided when the amount in controversy is between \$35,000 and \$50,000.

The Judicial Council is focused on providing high quality service to the public and SB 1141 furthers this goal because it will allow more cases to be referred to mediation, potentially easing court workload and ensuring timely adjudication of cases.
