Quarter 4

1. Row 17- adjustment of \$81,099.69 for 1st quarter error (cost was over stated by that amount).

2. Section I B - Civil Assessment - amounts reported do not include audit adjustment findings of -1,444,948 (December) and -362,336.52 (January). The amounts remitted on the TC -145 were net of the audit adjustments.

3. Section I B (row 17)- Adjustment of \$533.38 to 1st quarter court amount retained (adjustment made in 4th quarter). Court collections costs were understated by that amount.

4. Various audit adjustments *are* included in all other county and state revenues (including the revenues subject to the 50/50 excess split). Note: the figures that the County of Orange are reporting on their 50/50 excess revenue split calculation do NOT include any audit adjustments.

5. Section II B- Adjustments made to rows 71,72,73,75, and 80. The county penalty assessment distribution calculation was incorrect for Qs 1-3 and has been corrected so that the Q4 amount plus the adjustment equal the correct annual distribution to those funds.
