- 3. Row 63 (County General Fund): Added \$709.64, the amount under reported in Q3, to the Q4 total.
- 4. Row 70 (Night Court): Q3 amount was overstated because our Court had not finalized the calculation of what was to be redirected from the Court to the State. The Q4 amount reflects the negative Q3 adjustment of \$46,057.22.
- 5. Row 71 (Local Courthouse Construction Fund): Q3 total was under reported by \$104,096.66. The Q4 amount includes the amount under reported in Q3 plus Q4 actuals.
