1. RE: DNA Prop 69 AOC Acct No. 1715-070 CMS - Sustain JE programmer inadvertently flipped the two DNA collections distribution tables which allowed GC76104.7 collections to be reported as GC76104.6, causing an overstatement of the County 75% share DNA of GC76104.6 Prop 69 collections. The negative amount reported for Q4 adjusts the prior quarters accordingly to report the correct FY total collection of \$1973.

2. RE: Automated Fingerprint ID - AOC Acct No. 1710; Q4 is adjusted to include \$66 unreported Q3 revenue & \$8 unreported Q2 revenue.

3. RE: Court Construction Penalty Assessment - AOC Acct No. 1773, Q4 includes \$3898 incorrectly reported in Q3 as Surcharge on Parking (1779-010).

4. RE: Surcharge on Parking - AOC Acct No. 1779-010, Q4 adjust amount of (\$3898) incorrectly reported in Q3 which is actually Court Construction Penalty Assessment Revenue.
